Ridgeway Country Club offers 5 subcategories for each of its Membership Categories:

Personal Memberships:

Personal Memberships provide a lower food & beverage minimum spending structure to suit personal uses. It is a recreational membership that provides full access and privileges to all of the Club's facilities to include golf, practice facilities, locker rooms, club storage, clubhouse, dining, and involvement in all social related activities.

Business Memberships:

Business Memberships provide a lower dues structure with higher food & beverage minimum spending for the person who will utilize the membership for entertaining business clients, etc. It is a recreational membership that provides full access and privileges to all of the Club's facilities to include golf, practice facilities, locker rooms, club storage, clubhouse, dining, and involvement in all social related activities.

Corporate Memberships:

Corporate Memberships provide the same advantages as a Business Membership only a Corporate Membership requires more than one designee. In fact, there is a price break for each individual member when more designees are added to the membership. It is a recreational membership that provides full access and privileges to all of the Club's facilities to include golf, practice facilities, locker rooms, club storage, clubhouse, dining, and involvement in all social related activities.

Non-Resident Memberships:

Non-Resident Memberships are designed for individuals or families who do not live more than 60 consecutive days within 30 miles of Ridgeway Country Club. It is a recreational membership that provides full access and privileges to all of the Club's facilities to include golf, practice facilities, locker rooms, club storage, clubhouse, dining, and involvement in all social related activities.

Social Memberships:

Social Memberships provide a separate membership class at a very affordable fee for those people who don't wish to utilize golfing privileges frequently. It is a recreational membership that provides access and privileges to the Club's facilities to include clubhouse, and includes involvement in all social related activities. Includes unaccompanied access to Ridgeway Country Club golf facilities collectively four (4) times from May 15th - September 15th. Unlimited privileges from September 14th - May 15th. Standard Guest green fees apply to each round of golf played.
